Meetings of governmental bodies, including committees, are open to the public except for discussion of property purchases or personnel matters. Regular meetings permit time-limited comments from citizens during audience participation.



Before you vote, go to VOTE411.org for current election information. VOTE411.org is a "one-stop-shop" for voters where you can also find information about candidates, Michigan's registration requirements, your legislative district, polling place, etc.

All registered voters may **Vote by Mail**. Go to www.Michigan.gov/Vote to register to vote and to request a mail-in absentee ballot. Your ballot must be returned to the clerk's office, by mail or dropped off at your township clerk's office, by 8:00pm on election day.

2024 Election Dates

Tuesday, Feb. 27, 2024 – Presidential Primary

Tues., Aug 6, 2024 – Primary Election

Tues., Nov. 5, 2024 – General Election

To register to vote, you must be all of the following:

- A U.S. citizen
- At least 18 years old by Election Day
- A resident of Michigan and the City or Township where you are applying to register for at least 30 days before election day
- Not serving a sentence in jail or prison

Not sure if you are registered? Check online at www.Michigan.gov/Vote. There you will find information about registering to vote, absentee voting, **vote by mail**, voting equipment, polling place locations, state and local ballots, the candidates, campaign finance and more. Your local clerk can help with questions about your voter registration, polling place location and working at the polls.

The League of Women Voters (LWV) is a national, non-partisan political organization. LWV does *not* support or oppose political parties or candidates. We encourage informed and active participation in government. We work to increase understanding of major policy issues, starting with learning ourselves. REGISTER TO VOTE!!

Michigan Proposal 2, Voting Policies in Constitution Amendment (2022)

- Creates a nine-day early voting period;
- Requires voters to present photo identification or sign an affidavit when voting in person or applying for an absentee ballot;
- Requires that military or overseas ballots postmarked by election day are counted;
- Provides all voters with a right to request an absentee ballot;
- Requires the state to fund prepaid stamps and a tracking system for absentee ballots;
- Requires the state to fund a number of absentee ballot dropboxes;
- Provides that local governments can accept charitable and in-kind donations to assist with running elections as long as donations are disclosed and aren't from foreign entities and
- Provides that election officials are responsible for election audits, requiring election audits to be conducted in public, and requiring election results to be certified based on votes cast.

Proposal 2 also added constitutional language saying that "harassing, threatening or intimidating conduct." As well as laws, regulations, and practices, that have "the intent or effect of denying, abridging, interfering with, or unreasonably burdening the fundamental right to vote" are prohibited. To register to vote you must show **Proof of Residency**. You must prove 30 days of residency in your precinct. Documents that may be accepted as proof include a driver's license, a current utility bill, a current bank statement, a paycheck, a government check, or other government documents.

Voter assistance terminals are available at all polling locations, or you **may Vote by Mail as an Absentee Voter**.
